

AIMSCAP KR -TRADING BONUS PROMOTION

General Terms and Conditions

This promotion is offered by AIMSCAP Korea and is available from <u>1 Mar 2023 to 30</u> Jun 2023.

- 1. This promotion is available to existing clients of AIMSCAP and is applicable to the following AIMSCAP trading account types: Standard, VIP or Premium Account. AIMSCAP's clients from Greater China region or holders of AIMSCAP Islam Account does not qualify for this promotion.
